## Toner Recycling Program: Stop, Drop, Recycle



As part of our commitment to helping preserve the environment, Sharp offers our customers toner recycling for all Sharp consumables that results in zero waste to landfill, including: cartridges, bottles, toner collection containers and drum units.

We encourage customers to recycle their used Sharp toner cartridges in bulk by providing a pre-paid Recycling Kit for their return to our facility. Upon registration, customers will receive a recycling kit that contains 3 pre-addressed collection/shipping cartons. The carton can be conveniently placed in the customer's mailroom or near the copier for easy collection and shipment of up to 10 used cartridges.

On average, each month nine tons of used toner cartridges are kept out of landfills through our recycling efforts.
